CONDITIONS OF USE

1. The Club/Team will be responsible for the supervision and control of the group while using the Southern Districts Netball Association.

1.1 Supervisors must accompany children to toilets / facilities.

1.2 Local residents and their property must be always respected - no excessive noise, damage, or disturbance other than that required to run a netball program.

1.3 All participants must behave in an orderly manner. i.e., No swinging on the goal posts or drawing on the courts

2. The Club/Team must provide all equipment including first aid supplies.

3. The Club/Team is responsible for maintaining the condition of the facility. Toilets must be left clean, and the water fountain sometime sticks please give the button a light tap to ensure it turns off.

4. The Team is liable for any damage or loss to any part of the facility or equipment used, including goal posts.

5. No vehicle can be driven / ridden on the courts.

5.1 No Dogs or wheeled devices are allowed within the fenced area.

6. Courts will not be available for use on public holidays.

7. Whoever is the last Club/Team training here at the end of each night please close the main door to the disabled toilets door and gate before you go. And please lock the small as you leave.
